III. DESCRIPTION

Provide a brief description of the project or program on which you worked, the objectives of that project or program, and your role as an intern within that project or program:

The community program internship was designed to support NSEA's program team by facilitating community and student opportunities to engage with salmon and restoration activities throughout Whatcom County. The goal is to provide Whatcom County residents with hands-on experience in restoration and the tools/knowledge to act as stewards of salmon habitat. This is accomplished through several outreach opportunities including NSEA's Students for Salmon program, community work parties, Salmon Club, and salmon sighting events. As an intern, I was a facilitator and educator at all these events. I led Students for Salmon field trips alongside two of my fellow interns and taught 4th graders about macroinvertebrates, water quality, and native plants. After lunch, I also led the students in a smaller-scale restoration activity in which we removed invasives or planted native trees/shrubs. I was lucky enough to work as an educator/leader of salmon club, an after-school program offered at Birchwood Elementary aimed at getting students to engage with the outdoors. We would go on daily walks and teach 1st and 2nd graders about a broad range of environmental topics, not just about salmon. During community work parties I had several roles that ranged from collecting macroinvertebrates to leading a group of volunteers. More often than not I was a small group leader in charge of an average of 15 volunteers. As a small group leader, I introduced volunteers to the site, led tool safety, planting, and blue tube making demonstrations, provided support, and used that time to talk about salmon and riparian restoration. Similarly, during salmon sighting events I taught visitors about salmon, opening the floor to conversations about current threats to salmon habitat and restoration projects.

IV. DUTIES AND RESPONSIBILITIES

- Educated 4th-grade students about salmon and their habitat (including macroinvertebrates, water quality, and native plants) during Students for Salmon field trips
- Collected water quality data that was later entered into EarthEcho, a global database that collects water quality data from citizen scientists. Data collected included turbidity, DO levels, water temperature, and macroinvertebrates found
- Led volunteers during community work parties where I was in charge of giving tool safety, planting, and blue tube making demonstrations
- Educated volunteers and community members about threats to salmon and ongoing restoration projects/efforts at community work parties and salmon sighting events
- Taught 1st and 2nd graders about a variety of environmental topics (e.g., salmon, the ocean, invertebrates, watersheds) during Salmon Club meetings
- Worked collaboratively with fellow interns to plan, organize, and successfully carry out events
- Assisted in miscellaneous tasks (e.g., set up/clean up of events, tool maintenance, flyering for events, making new program materials, social media content creation)

V. LEARNING OBJECTIVES

Describe what you learned from your internship and how this experience contributed to your educational goals:

This internship has increased my overall confidence in having conversations about salmon, habitat restoration, and the environment. There were several opportunities throughout my time at NSEA to attend Salmon 101 trainings where we had speakers come in and teach us about salmon and open the floor to questions. I was also able to learn a lot from the Washington Conservation Corps (WCC) crew and restoration technician crew about specific restoration projects NSEA was undertaking. Moving into the spring NSEA is doing a lot of culvert removal and bridge building to eliminate barriers to migration and spawning while flows are low. Being surrounded by such knowledgeable people and being able to connect with these people on a daily basis has broadened my understanding and knowledge surrounding threats to salmon and habitat restoration. I was also able to get to know Amy and Anitra and learn more about grant writing and what goes into running a non-profit. NSEA has also supported me job-wise by hosting resume workshops that I took advantage of. During work parties, salmon sighting events, and Students for Salmon field trips, even though I took on more of an educator and facilitator role, I was still able to learn a lot from my peers and volunteers that I engaged with. Connecting with such a diverse group of people in terms of age and background

has broadened my perspective and general knowledge about the environment. I met a woman named Holly who taught me all about macroinvertebrates and lampreys and a man named Don who taught me about storm drains and rain gardens. Holly and Don are just a few examples, but without NSEA I wouldn't have had the opportunity to connect with these people and learn as much as I did. My goal academically and personally is always to learn as much as possible. Through this internship, I was also able to develop a lot of soft skills such as leadership, collaboration, and communication skills that will benefit me in the long run. I also used this internship as an opportunity to gain real-world experience and explore potential areas of interest and career avenues. When thinking about graduate school and post-grad this experience will not only bolster my resume but will also guide and help me decide what I want to do in life.

Payton: "I want to feel more confident in doing the work party intro. I've only actually done the intro once or twice and usually just do tool safety and planting demos. I also think that while giving these/addressing a bigger group I could do a better job of projecting my voice, sounding more confident in what I'm saying, and looking up/making eye

. This can translate to public speaking in any context. Practice allows for more confidence, and I think you appear more confident than you give yourself credit for.

I definitely do a better job with talking to volunteers 1 on 1 or in a small group. I think compared to last year I've definitely gotten better about being more of an outward leader but I can always improve.

- I feel like when I've observed you engaging with volunteers, you do a great job. Maybe you can practice effectively initiating and ending conversations, and chatting with folks you wouldn't typically approach. This is something you can test run this weekend at the 6/1 WP.
- I also wish that my schedule would have allowed me to shadow one of the restoration techs throughout their day just so I could learn more about what they do and also about the different kinds of restoration activities they do. At work parties we only really see planting and invasive removal which I know is probably the bulk of it."
